Valentina Balestracci is a master's student at the University of Pisa. Her research interests are Hegel, Wittgenstein and theoretical philosophy. She is currently writing her thesis on Wittgenstein and grammar in the *Tractatus*.

Alexander Berg has studied at the TU Dresden, the Sorbonne (Paris) and the University of Florence. Following research stays at the Wittgenstein Archives (Bergen), Wren Library (Trinity College, Cambridge) and the University of Chicago, he defended his PhD thesis Absolutes Wissen und Grundlose Gewissheit – Hegel und Wittgenstein at the TU Dresden. He has published on Wittgenstein, Hegel, Heidegger and Charles Taylor and teaches at the Faculty of Humanities, Charles University (Prague).

Lorenzo Cammi received his PhD from Leipzig University and the University of Verona for a dissertation on Hegel's metaphysics. In 2011 and 2013/2014 he was a Visiting Scholar at the University of Pittsburgh, and in 2014/2015 he was a Visiting Fellow at Harvard University.

Gaetano Chiurazzi is Associate Professor of Theoretical Philosophy at the University of Turin. He has studied and worked as a Research Fellow at the universities of Turin, Berlin, Heidelberg and Paris. His interests centre on French and German philosophy, in particular Derrida, Kant, Hegel, Husserl, Heidegger and Gadamer. His book *Modalità* ed esistenza about Kant, Husserl and Heidegger has been translated into German as *Modalitàt und Existenz* (2006). With Gianni Vattimo, he is co-editor of *Trópos. Rivista di ermeneutica e critica filosofica*.

Bruno Haas is Professor for Philosophy and Art History at the TU University of Dresden and maitre de conférences at the Sorbonne (Paris 1). Major publications include Beiträge zu Hegels Wissenschaft der Logik, der Kunst und des Religiösen (2003); Die ikonischen Situationen (2015); "Urteil" (2017).

Kai-Uwe Hoffmann is a Lecturer at the University of Auckland (New Zealand). He also acts as the representative of the German academic community in New Zealand. Prior to coming to Auckland, he held lecturer positions at the University of Jena (Germany) and Durham University (UK). Over the last four years, he worked as a representative on behalf of the German parliament. His current central research interests concern thick aesthetic concepts, theories of beauty, normativity, semantics, pragmatics and metaphysics.

Herbert Hrachovec was Professor for Philosophy at the University of Vienna until his retirement in 2013. His research covers continental and analytic philosophy and, more recently, the theory of new media. He administers a number of web services, including an Open Access repository of "electronically archived theory" (sammelpunkt.philo.at) and a collection of philosophical audio recordings (audiothek.philo.at).

Karl-Friedrich Kiesow is a researcher at the Institute for Philosophy, University of Hannover. He wrote his PhD on the philosophy of nature and epistemology of objective empiricism. He

is now working on a book about Alfred North Whitehead's impact on the history of 20th-century biology.

Marco Kleber is a Research Assistant at the Department for Philosophy, TU Dresden. He researches and teaches on topics including Hegel, dialectics, political and practical philosophy, critical social philosophy and philosophy of language. He was co-organiser of the conference "Hegel and Wittgenstein: Reevaluation of Difference", and is currently working on his PhD thesis on Hegel's linguistic—analytic foundations of political philosophy.

David Kolb is Professor Emeritus of Philosophy at Bates College (Maine, USA). Inspired by classical German philosophy, especially Hegel, he has published books and articles on the tensions of modernity's new modes of unity in society, architecture and modes of writing: *The Critique of Pure Modernity: Hegel, Heidegger, and After* (1987), *Postmodern Sophistications* (1990), *Sprawling Places* (2008, and at dkolb.org) and *Socrates in the Labyrinth* (1994). He also edited *New Perspectives on Hegel's Philosophy of Religion* (1992).

Vojtěch Kolman is Associate Professor at Charles University (Prague). His main specialisations are Gottlob Frege, philosophy of mathematics, philosophy of language and philosophical logic. His recent publications include a book entitled *Zahlen* and the article "Hegel's Bad Infinity as a Logical Problem" in the *Hegel Bulletin*.

Wilhelm Lütterfelds was a Professor for Philosophy at the University of Passau (Germany) from 1985 until his retirement in 2009. From 2012 until his death in 2018 he was an Honorary Professor at KU Linz (Austria).

Jakub Mácha is Associate Professor at the Department of Philosophy, Masaryk University (Brno, Czech Republic). He has published on analytic philosophy and classical German philosophy. His most recent book is *Wittgenstein on Internal and External Relations: Tracing All the Connections* (2015).

Ingolf Max is Adjunct Professor of Analytic Philosophy and Logic at Leipzig University (Germany). His main areas of interest are multidimensional logics, logic of music, philosophy of language and Wittgenstein's philosophy. His recent articles include "The Harmony of Colour Concepts: Bridging the Early and the Late Wittgenstein" (2017) and "A Molecular Logic of Chords and Their Internal Harmony" (2018).

Aloisia Moser is Assistant Professor at KU Linz (Austria). She was awarded a PhD by the New School for Social Research (New York) and conducted her post-doc studies at UC Berkeley and in the research centre Analytic German Idealism at Leipzig University. Her book Kant and Wittgenstein – A Groundwork for a Theory of the Act of Thinking is due to be published in 2019.

Terry Pinkard is Professor at Georgetown University, known for his work on the German tradition in philosophy from Kant to the present. His books include *German Philosophy 1760 – 1860: The Legacy of Idealism* (2002), *Hegel's Naturalism: Mind, Nature, and the Final Ends of Life* (2012), and *Does History Make Sense? Hegel on the Historical Shapes of Justice* (2017). He also translated Hegel's *Phenomenology of Spirit* into English (2018).

Ermylos Plevrakis obtained his PhD from the University of Heidelberg (2016). Ever since, he has been lecturing on philosophy at the universities of Heidelberg, Tübingen and Jena. His research focuses on the relation between logic and metaphysics from Aristotle to Wittgenstein. He is the author of Das Absolute und der Begriff: Zur Frage philosophischer Theologie in Hegels Wissenschaft der Logik (2017).

Valentin Pluder received his PhD from the University of Bochum for his dissertation on the mediation of idealism and realism in classical German philosophy. Between 2014 and 2016. he was the Custodian of the Hegel Archives in Bochum. Since 2016, he has been a Lecturer at the University of Siegen (Germany).

Paul Redding is Emeritus Professor of Philosophy at the University of Sydney. He is known for his research on Kantian philosophy and the tradition of German idealism and its relation to analytic philosophy and pragmatism. He is the author of Analytic Philosophy and the Return of Hegelian Thought (2007) and Continental Idealism: Leibniz to Nietzsche (2009).

Thomas Rentsch is Professor of Practical Philosophy at TU Dresden. His research covers philosophy of language, ethics, philosophical anthropology, aesthetics, philosophy of religion, political philosophy, hermeneutics, history of metaphysics, phenomenology and gerontology. His books include Heidegger und Wittgenstein: Existential- und Sprachanalysen zu den Grundlagen philosophischer Anthropologie (1985), Die Konstitution der Moralität: Transzendentale Anthropologie und praktische Philosophie (1990) and Philosophie des 20. Jahrhunderts: Von Husserl bis Derrida. (2014). He is co-editor of the Historisches Wörterbuch der Philosophie (1971 - 2007).

Tom Rockmore is Distinguished Professor Emeritus at Duquesne University (Pittsburgh, USA), as well as Distinguished Humanities Chair Professor at Peking University. His main focus lies in epistemology, philosophy of German idealism, political philosophy and aesthetics. His books include Hegel, Idealism and Analytic Philosophy (2005) and Marx's Dream: From Capitalism to Communism (2018).

Jonathan Shaheen is currently a Postdoctoral Research Fellow at the University of Uppsala (Sweden) and a Postdoctoral Researcher of the FWO. He completed his PhD at the University of Michigan on the topic of "metaphysical explanation and grounding". His primary research programme combines philosophy of language, metaphysics and philosophy of science, and he has several publications on these topics.

Pirmin Stekeler-Weithofer is Professor of Theoretical Philosophy at Leipzig University. He has written widely on philosophy of language, action theory, logic and the relationship between classical and analytic philosophy (Plato, Kant, Hegel).
